Virus claims 36 more lives in Punjab

LAHORE: During the last 24 hours, coronavirus claimed 36 more lives in Punjab, pushing the death toll to 475 in the province from the deadly virus.

According to a spokesperson for the Punjab Primary and Secondary Healthcare Department on Sunday, the virus affected 534 more citizens in the provincial capital during the last 24 hours, and the registered number of cases reached 12,213 with the new infections. Also, 952 new cases of COVID-19 were registered across the province, which increased the number to 25,056 cases. The Health Department confirmed that 19 cases were registered in Nankana Sahib district, eight in Kasur, 86 in Rawalpindi, four cases in Jehlum,

Attock police recover cannabis

Covid casualties

HE Odaily number of new infections of coronavirus in Pakistan is going into thousands. This is not an entirely unforeseen scenario. Experts in medical science and doctors have been crying hoarse for at least the past two months for us to take the disease seriously. They have urged the government to enforce its SOPs and make sure that the spread of the virus is contained.

They have also been calling on people not to consider Covid-19 as a drama of sorts, as many on social media have been propagating. With nearly 1400 deaths in Pakistan, it should be evident enough for everyone to believe the doctors. But it seems that the pandemic has not only brought human casualties in its wake, there have been some other casualties too, which the government and the people have precipitated with their lax responses to the virus. These casualties will result in many more deaths if we keep our refusal to face them.

Sanity appears to be a major casualty in the country as people are losing their minds and tempers at the same professionals who have been trying to protect them. Doctors, paramedical personnel, and janitorial staff are the ones who are at most risk, as they are treating thousands of people on a daily basis. They are putting their own lives in danger so that the people infected with novel coronavirus can be saved.

But all sanity appears to be lost not only to the patients who refuse to accept their medical condition, but also to those who accompany the patient. Clinics and hospitals have been attacked, emergency rooms ransacked, and even doctors and nurses maltreated by those who accompany patients. The recent display of violence at Civil Hospital in Karachi is a case in point.

This behaviour is the result of the failure of our state to provide security to medical establishments. There is an urgent need to deploy security to maintain law and order around hospitals, and to enforce the SOPs in cities especially in congested areas.

This is a war-like situation and many countries have declared a state of emergency. The same needs to be done in Pakistan.

The government has been taking it pretty lightly prompting the people too to respond with non-seriousness in this matter. Now there is even talk about allowing all public transport to operate.

It is a matter of grave concern that despite such a big number of infections every day, the authorities can even think of allowing public transport. This is no laughing matter and should be dealt with utmost care and consideration. The government must heed the pleas of doctors, provide them full security, and avoid such steps that will result in a precipitous rise in casualties.

Locust attacks

S this newspaper has highlighted many times earlier, locust attacks are increasingly becoming a nightmare for local farmers and people alike. Though the locust swarms have already entered Pakistan and are wreaking havoc in many districts, an even more severe locust attack is expected after a month. As if the impact of coronavirus was not devastating enough, now the locust problem has added to the woes of an ill-prepared National Disaster Management Authority (NDMA).

If not handled properly and in time, it may develop into a severe crisis that will destroy fields with much-needed food supplies both in India and Pakistan. If India and Pakistan fail to cooperate with each other and don't make coordinated efforts, locusts will impact food security in this region. These short-horned grasshoppers have already invaded agricultural fields in Balochistan, Sindh, and South Punjab and have triggered a risk of famine in the region.

Desert locusts are not a new phenomenon in this region and have been invading for decades, but despite this usual occurrence, India, Iran, and Pakistan fail to pool their resources and technical expertise right at the outset when the swarms start developing. In this matter, India and Pakistan should be playing a leading role as they have the most resources in aircraft and preventive sprays.

Perhaps, it is the perennial ill will between the two countries that prevents coordinated efforts other than just informing each other. Ideally, Pakistan should have reacted promptly, and India should have offered its aircraft to Pakistan to spray the fields and kill the locust. Whenever they came, locusts devoured large quantities of crops and this time is no different. In Pakistan they are reported to have already swarmed over 60 districts in all four provinces, starting from Balochistan. The speed of swarms is reported to be around 150 kilometres a day so it should not have been that difficult had we allocated enough resources and rented or requested more aircraft for spraying.

The Food and Agriculture Organization (FAO) has also been warning Pakistan that nearly forty percent of the country's fields will become breeding grounds for these insects if timely actions are not taken. The estimated financial loss to the country may be around 600 billion rupees. From here, the swarms are moving towards the Indian capital New Delhi, and western Indian states of Gujarat, Maharashtra, and Rajasthan.

Now, in addition to tackling the current locust crisis, the countries of this region need to reflect about the miseries of their citizens caused by such invasions and compounded by the inability of India, Iran, and Pakistan to join hands and act swiftly before another swarm hits the region in July.

COVID-19 Crisis: An unprecedented push For SDGS action

Whenever the world experienced a health crisis, it provided an opportunity for creating major changes. For instance, all spheres of political leadership in the global system interact, reinforce, and implement adaptive decisions at much faster pace in response to humanitarian emergencies

HE current financial market turmoil, crude oil prices slump and temporary truce in all armed conflicts around the world in response to the COVD-19 pandemic chaos makes it clear that the intrinsic value of health sector goes beyond its contribution to human development.

The catastrophic impact of COVID-19 crisis and the highest one-day death toll being reported in developed countries starkly spotlights the centre of gravity on the health related issues that receive a lot less attention than economic sector, but are equally or perhaps even more crucialfrom a long-term development perspective for developed as well as developing countries.

The massive educational, business, industrial and

other workplaces closures hinge strongly on the premise that no one isleft behind in terms of health is crucial as a precondition and driving force for inclusive economic growth and development, poverty alleviation and universal access to education. In view of inadequate responses to the Millennium Development Goals to overcome the challenges of a changing climate and weather extremes, conflict, inequality, hunger and malnutrition, water insecurity, rapid urbanization and disease outbreaks that left us all more vulnerable, several countries learned their lessons and responded far more rapidly to United Nations' universal call to action for SDGs.

As actions which may contribute to one of the SDG targets may also have an impact on other targets, SDGs are quite clearly more interdependent and integrated. Such recognition is especially crucial as some overarching issues, such as pandemics, can affect multiple targets simultaneouslyand exponentially. For instance, the ranking of some of the countries with leading positions according to their GDP (PPP) per capita drops significantly in the Human Development Index when economic dimensions of health inequality is taken into account. Likewise, the relationship between the role of health equity and growth in ICTs adoption also works both ways around. Such interlinked nature of SDGs and its explicit health-related targets provide a new context as there is a health component affecting achievement of many of the targets such as attaining gender equality, reducing poverty and improving education, not just those under SDG 3 (Good Health & Well-being - Ensure healthy lives and promote well-being for all at all ages).

Following the UN Sustainable Development Summit, held for the adoption of the post-2015 development agenda, and in response to the global emergence of more than thousand epidemic events in more than hundred countries in just 15 or so years, some hopeful signs were seen during 2016-2017, when UN Secretary-General's Global Health Crises Task Force (in 2016) and WHO-World Bank joint Global Preparedness Monitoring Board (in 2017) were established to mobilize and strengthen collective national, international and multilateral action for global health security and emergency preparedness.

But despite considerable economic upheaval caused by viral outbreaks, and clearly identified mechanisms and policy solutions by the relevant health panels, an overwhelming majority of countries failed to make a fundamental shift in their health policies and were unprepared for the next devastating pandemic outbreak.SDGs provided both an obligation and an opportunity to the leaders to rethink development systems and approaches to overcome problems to collective action in the social, economic, and environmental dimensions of sustainable development.

Whenever the world experienced a health crisis, it provided an opportunity for creating major changes. For instance, all spheres of political leadership in the global system interact, reinforce, and implement adaptive decisions at much faster pace in response to humanitarian emergencies.

The current situation suggests a clear need to adopt a coordinated approach which may not focus solely on overcoming the crisis but ensure effective short and long-term initiatives with engagement of all political stakeholders, civil society actors, private sector and public institutions to better design the frameworks and responses to make the best use of the synergies between different goals as well as to manage aftermaths of pandemics. One such capacity that is now more relevant than ever is of the digital and mobile technologies in healthcare delivery system.

Calls for concerted action for strengthening the institutional foundations to support developing countries in their efforts to harness S&T for their sustainable socio-economic uplift came following the United Nations Conference on Environment and Development (UNCED) in 1992.

One of the earliest and thoughtful contributions made in this vein was by Pakistani Nobel Laureate, Prof. Dr. Abdus Salam, whogave the idea of establishing an Intergovernmental platform, the Commission on Science and Technology for Sustainable Development in the South (COMSATS), for providing visionary leadership to developing countries for utilizing and mobilizing STI as an integral component of strategies for promoting sustainable development.

At its inception as a high level forum of regional cooperation in S&T, represented by Heads of State/ Government, COMSATS assumed an advocacy role for sensitizing the relevant government machinery in its 27 Member Statesfor investing in STI for development and encouraging the decision-makers to strongly interact with the scientific community to incorporate relevant mechanisms and policies in their activities and development agenda.

A platform for the latter was also made available in the form of a network of 22 renowned International Science and Technology Centres of Excellence. COMSATS is mandated to facilitate achievement of sustainable socio-economic development in the South long before the realization of 2030 Global Agenda.

The major initiatives of COMSATS that laid solid foundations for STI development included, inter alia, establishment of high-quality educational institutions (COMSATS University) and Infrastructure (COMSATS Internet Service); International Thematic Research Groups (ITRGs) for promotion of cutting-edge research using multi-, Inter-, and transdisciplinary approach; COMSATS Telehealth program (CTH) pioneer in using ICTs application for providing healthcare in community-based settings; COMSATS Centre for Climate & Sustainability (CCCS) a broad coalition of academic and research institutions and organizations working on environmental risks to achieving Sustainable Development Goals (SDGs); and various group training courses and workshops for technologists and practitioners from its Member Countries for building and strengthening education and research capacities.

To join and support COVID-19 response efforts and to carry on the momentum of progress towards achieving SDGs, COMSATS aims to give better insight into wide range of social, economic and environmental determinants of health, bring the regional- and national-level discussions with a multi-sectoral approach on mitigating the socio-economic impact of this crisis and alongside improving capacities and skills of personnel working across health and health-related disciplines.

America's withdrawal from the WHO is unhealthy

S President Donald Trump suspended US involvement with the World Health Organization (WHO) on May 19, and threatened that the US would withdraw completely unless the WHO undertook "substantive reforms" within 30 days.

The president did not even wait 30 days. Last Friday he said the US would "today be terminating our relationship with the World Health Organization and redirecting those funds to other worldwide and deserving urgent global public health needs."

But what does "today" mean? The US was a founding member of the WHO in 1948, when Congress passed a resolution later approved by the organization allowing for the US to leave with a year's notice. Terminology matters in international law, which leaves the president's announcement somewhat imprecise.

There are other implications. The US gives more money to the WHO than any other contributor. In 2019 the organization's budget was \$5.6 billion, of which 17 percent was "assessed" country contributions and 80 percent was voluntary. The US paid \$419 million, of which \$119 million was assessed and \$300 million was voluntary. And the damage from the US withdrawal, whatever form it takes, goes beyond finance; it matters to the world at large.

The WHO has myriad constituents; member countries, other contributors, or collaborators such as the Bill & Melinda Gates Foundation. The organization values its prized access to national governments and their health data and research facilities, which explains why it errs on the side of diplomacy and criticizes member countries behind closed doors rather than in public.

The damage from the US withdrawal from WHO, whatever form it takes, goes beyond finance; it matters to the world at large.

Cornelia Meyer: After withdrawing, the US could still collaborate in open programs in which the WHO participates. The only program that is bespoke to the organisation is polio eradication, which nobody can deny is a worthwhile and important mission.

Other than through its programs, the WHO collaborates with 82 US research institutes, 21 of which are based at the Centers for Disease Control and Prevention. Canceling that collaboration would have a devastating impact, given the pre-eminent US position in medical and pharmaceutical research.

pre-eminent US position in medical and pharmaceutical research. It is true that, like other UN institutions, and indeed the UN itself, the WHO would benefit from reform. However, all in all, the world

needs the WHO and the WHO needs the prow-

ess of America's research and development capability. One could also argue that the US needs the network and access to public health issues and emergencies that the WHO provides, especially as it withdraws more and more from the multilateral global architecture.

Last, and probably most important, we have to be aware that the next battle against COVID-19 will not be fought in the hospitals of New York or Chicago. It will be fought in Kano, General Santos and Manaus. The virus is rapidly moving to the southern hemisphere, where health-care systems are less developed and there is no funding, especially in developing countries. When it takes hold there it will affect the weakest of the weak with little or no access to medical care. It will affect people in slums where hygiene measures and social distancing are either inaccessible or impossible.

The world at large will find out that we are all our brother's keeper, when the virus rebounds from the southern hemisphere to the streets of New York and Paris. We all have an interest in organizations such as the WHO being able to do their work with cooperation from every country.

Unrest sweeps US as protest continue

MINNEAPOLIS: Violent protests erupted across the United States late Friday over the death of an unarmed black man at the hands of police, with murder charges laid against a Minneapolis officer failing to quell seething anger.

Demonstrators clashed with police for a fourth straight night in the midwestern city of Minneapolis, where fires raged and there was widespread looting as well as sustained cat-and-mouse clashes between protesters and police. US President Donald Trump ordered soldiers prepare to deploy to the city, Minnesota National Guard General Jon Jensen confirmed early Saturday. The state has become the epicenter of violence since George Floyd died there in an arrest by an officer who pinned him to the ground for several minutes by kneeling on his neck.

This is not a protest, this is chaos, says Keisha

ATLANTA: Atlanta Mayor Keisha Lance Botms on Friday evening denounced vandalism in her city as "chaos" after demonstrations over the death of George Floyd while in in the custody of Minneapolis police turned violent.

"What I see happening on the streets of Atlanta is not Atlanta. This is not a protest. This is not in the spirit of Martin Luther King, Jr. This is chaos," an impassioned Lance Bottoms said at a news conference.

"A protest has purpose. When Dr. King was assassinated, we didn't do this to our city," she said. "If you want change in America, go and register to vote. ... That is the change we need in this country." The protests had started as peaceful Friday afternoon when crowds gathered in the city's famed Centennial Park. But by 6 p.m. ET, protesters began moving toward the front of the Center, where police had gathered.

SC fixes **BRT** case for June 3

Chinese lad devotes 3 years to improving rice production in Pakistan

BEIJING: "Agriculture in Pakistan still relies heavily on manpower, and my goal is to promote advanced agricultural technologies and hybrid rice in this country to improve rice production and alleviate the burden of farmers. " A Chinese young man Dai Yingnan said.

Wearing a Pakistani costume of long robe matched with a farmer straw hat, Dai Yingnan strode barefoot through a patch of hybrid rice field, observing the status of the crop. That is the image of Dai Yingnan who has been promoting the plantation of hybrid rice in Pakistan for 3 years, reports Gwadar Pro on Saturday.

Born in a village of Liaoning Province in northeast China,

the post-90s boy had personal experience of growing corn and rice with his parents when he was little, and therefore had a deep understanding of the hardship of farmers.

The turning point appeared when Dai Yingnan, as representative of his university, had an opportunity to talk to Yuan Longping, "Father of Hybrid Rice". "When I was confused about the prospect of agronomy, the esteemed man told me that 'agriculture that sustains the life of people is the foundation of a country.

At the same time, It's a slow-growing industry that requires the accumulation of time and people devoted to it. 'He encourages us to find truth in fields. " Dai recalled. After graduation in 2017, Dai got an offer from Yuan Longping High-tech Agriculture



Company with Yuan Longping serving as Honorary Chairman and was later assigned to Pakistan to promote hybrid rice.

"I never thought I would love this work until I was stranded at home for almost half a year due to the COVID-19 pandemic. I really miss the farmlands in Pakistan." Dai said.

Carrying out research and promoting the plantation of hybrid rice in Pakistan is never an easy job. Dai had to select one type of seed that is most suitable for the local environment out of thousands of seeds, which demands years of experiments. One of the best ways to find the right seed is to plant hybrid rice in test fields. And it needs careful observation and detailed records on the growing process of the plants from sowing, blooming, to harvest. One missing or false record would lead to failure of the

experiment that usually

costs at least half a year. Pakistan's torrid weather is another bigger challenge for the young chap growing up in a cooler place in China. The temperature in Pakistan in summer can reach nearly 50. partnered with fierce sunlight and strong dust. When walking in rice fields, anyone will be sweating and unkempt.

"After three years of touring between cities of Pakistan for the experiment, I get suntanned and look 10 years older than my peers." Dai quips.

Since April 2018 Dai began to make short videos to record his life and work in Pakistan and shared one or two per day on Chinese social media platforms. So far, He has posted more than 500 videos, attracting around 165,000 followers. "Pakistani people are immensely hospitable." Dai

highlighted. "Once a farmer invited me to have dinner at his home for thanking me to provide guidance on the plantation of hybrid rice and when I sat down at the table, I found a pair of chopsticks specially prepared for me. I was very touched by their thoughtfulness at that moment, because I knew they had to buy the chopsticks for me from a town away from here."

In October, the harvest month every year, the yield of hybrid rice is apparently higher than the locally grown rice, and even twice in some places by comparison.

"I used to invite local farmers to share the joy of harvest when we reap the hybrid rice because I have a feeling of accomplishment when I see smiles on their faces," Dai said with a beam of happiness.

TASHKENT: Dr. Muhsinjon M. Kholmukhamedov Center for Economic Researches and Reforms Until mid-March, residents of Uzbekistan - a doubly landlocked state - experienced the coronavirus epidemic with some degree of surprise: the epidemic, which originally found in China, circled the center of Asia and began to spread in Europe. On March 15, Uzbekistan officially announced the detection of the first case of coronavirus infection in a citizen who arrived from France. 2 months passed and during this time the number of infected COV-ID-19 on May 19, 2020, has reached 2802 people, of which 2314 (82.6%) recovered, and 13 - died. The mortality rate in Uzbekistan re-

mains extremely low - 0.46% of the total number of cases. In the fight against coronavirus in Uzbekistan, the best features of the Uzbek society were manifested: general support of the population and quickly mobilized government apparatus.

On the other side, the introduction of restrictive measures against the pandemic paralyzed both formal and informal economies, which left most of the country's population without a subsistence. Social protection systems are crucial to safeguarding the poor and vulnerable during coronavirus pandemic and crises hit.

As of May 8, 2020, a total of 171 countries (12 more since last week) have planned and adapted 801 social protection measures in response to COVID-19. Social assistance transfers keep remaining the most widely used class of interventions (60.7% of global responses, or 487 measures). These are complemented by significant contribution in social insurance and labor market-related measures (supply-side measures). In addition, 246 (30.7%) of COVID-related measures goes to cash transfer programs.

Together with wage subsidies, countries are strengthening their active labor market programs, particularly intermediation services and skills training. Graph.1. Key measures taken by the Government of Uzbekistan in response to the coronavirus pandemic. Uzbek government is also announced 3 packages of social assistance measures and labor market interventions by the Government of Uzbekistan[1] (GraphÄ1) . Social Security Priority As a result of quarantine, economic activity of 196 thousand enterprises were significantly dropped, and about 95 thousand individual entrepreneurs suspended their activities.

The World Bank estimates that the impact of coronavirus infection through declining household incomes and remittances will increase poverty in 2020. Pandemic Risk Groups At the same time, direct state aid cannot always reach all objective groups, mainly the groups of people whose income plummeted due to coronavirus and lockdown measures. First of all, this concerns the informal economy and labor migrants. Accounting for the incomes of citizens employed in these sectors is very difficult for some objective reasons, which further creates difficulties in classifying them into the support group. Even in the most developed countries of the world, the shadow economy is at least 7.5% of GDP. According to UNDP estimates in 2019,

the size of the shadow economy in Uzbekistan varies between 40% and 50% of GDP. Furthermore, according to the international non-governmental non-profit organization BUYUK KELA-JAK, the size of the shadow economy in Uzbekistan reached 50% of GDP in 2019. On the report of World Bank, the total number of employees in Uzbekistan in 2019 amounted to 13.2 million people. Of these, 7.9 million informally employed (59.8%) and 5.3 million formally employed (40.2%). The ratio of formal and informal employment by type of activity in Uzbekistan*

(thousand people) * As of the 1 st January 2020 This implies that more than half of the economically active labor force of the country is not covered by social insurance, which makes them more vulnerable to the consequences of pandemic.
